ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of W. L. McDaniel, et. ux., Building and Land Development Division File No. 180-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. W.L. McDaniel, et. ux. petitioned on May 17, 1978, that the property described in Section 3 below be reclassified from RS 7200 (Potential RM 900) to RM 900 and this application was assigned Building and Land Development Division File No. 180-78-R.

SECTION 2. This report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on August 3, 1978, and hearing was held by the Examiner on the matter August 10, 1978. The report of the Examiner was filed with the Clerk of the King County Council on September 5, 1978, and the Council approved the reclassification by Motion No. 03726 on September 11, 1978, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
