5 ORDINANCE NO. 4030

6 AN ORDINANCE amending King County Zoning Resolution  
7 No. 25789, as amended, by amending the Zoning Map  
8 thereof reclassifying certain property thereon at  
the request of Ethel M. Murray, Building and Land  
Development Division File No. 252-78-R.

9 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

10 SECTION 1. Ethel M. Murray petitioned on February 28, 1978,  
11 that the property described in Section 3 below be reclassified  
12 from RS 7200 (Potential RM 1800) to RM 1800 and this application  
13 was assigned Building and Land Development Division File No.  
14 252-78-R.

15 SECTION 2. The report and recommendation of the Building and  
16 Land Development Division was transmitted to the Zoning and Sub-  
17 division Examiner on June 15, 1978, and hearing was held by the  
18 Examiner on the matter June 22, 1978. The report of the Examiner  
19 was filed with the Clerk of the King County Council on August 21,  
20 1978, and the Council approved the reclassification by Motion No.  
21 03770 on October 9, 1978, subject to conditions which will be satis-  
22 fied per the "P" suffix.

23 SECTION 3. The legal description of the property to be re-  
24 classified is attached as Appendix A and is hereby made a part of  
25 this ordinance. The above described property is shown on the at-  
26 tached map which is designated Appendix B and is hereby made a part  
27 of this ordinance.

28 SECTION 4. The King County Council does hereby amend King  
29 County Zoning Code, Resolution No. 25789, as amended, by reclassi-  
30 fying that property described and shown in Section 3, Appendices

1 A and B above, to RM 1800-P and directs that Area Map E 22-23-4 be  
2 modified to so designate.

3 SECTION 5. This reclassification is granted subject to con-  
4 ditions adopted in Motion No. 03770 and said conditions are incor-  
5 porated herein as though fully set forth herein.
