5 ORDINANCE NO. 4081

6 AN ORDINANCE amending King County Zoning Resolution
7 No. 25789, as amended, by amending the Zoning Map
8 thereof reclassifying certain property thereon at
the request of Allan M. Deutsch, et. al., Building
and Land Development Division File No. 157-77-R.

9 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

10 SECTION 1. Allan M. Deutsch, et. al., petitioned on July 7,
11 1977, that the property described in Section 3 below be reclassi-
12 fied from SR to BN and RM 900 and this application was assigned
13 Building and Land Development Division File No. 157-77-R.

14 SECTION 2. The report and recommendation of the Building and
15 Land Development Division was transmitted to the Zoning and Sub-
16 division Examiner on September 6, 1977, and hearing was held by
17 the Examiner on the matter September 13, 1977. The report of the
18 Examiner was filed with the Clerk of the King County Council on
19 November 10, 1977, and the Council approved the reclassification by
20 Motion No. 03299 on November 14, 1977.

21 SECTION 3. The legal description of the property to be re-
22 classified is attached as Appendix A and is hereby made a part of
23 this ordinance. The above described property is shown on the at-
24 tached map which is designated Appendix B and is hereby made a part
25 of this ordinance.


26 SECTION 4. The King County Council does hereby amend King
27 County Zoning Code, Resolution No. 25789, as amended, by reclassi-

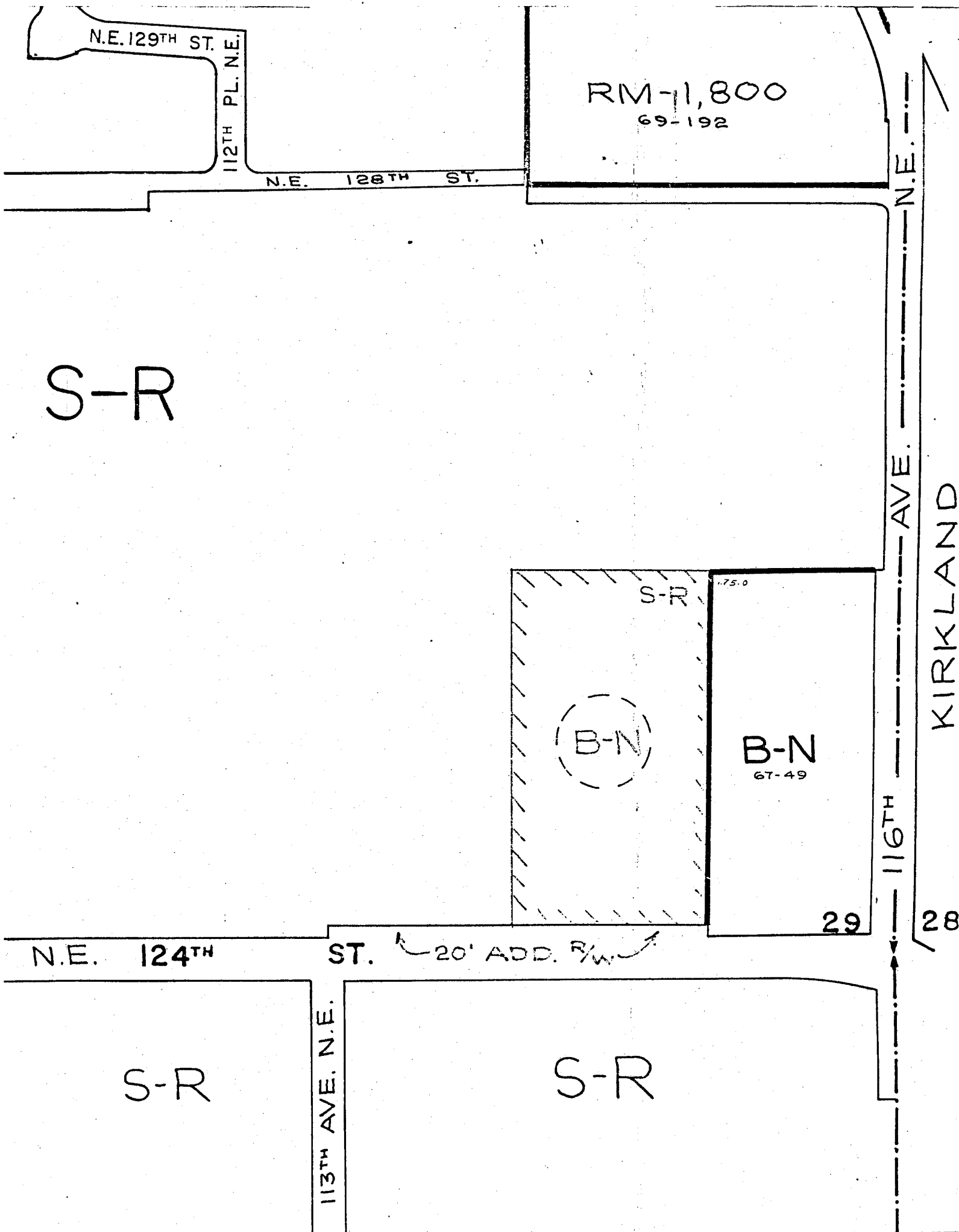
