ORDINANCE NO. **4101**

AN ORDINANCE relating to the annexation of an area known as Herold to King County Water District No. 19.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Herold to King County Water District No. 19 was filed with the County Council effective December 11, 1978.

2. King County Water District No. 19 has found the petition for annexation to be sufficient and has, by Resolution 385, concurred with the proposed annexation.

3. King County Water District No. 19 filed a Declaration of Nonsignificant Impact dated June 9, 1978, on the proposed annexation.

4. The County Council held a public hearing on the 15th day of January, 1979, and has considered the criteria set forth in RCW 57.01.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 19 of the area known as Herold and described in Section 2 herein is approved.

SECTION 2. The area known as Herold to be annexed is described as follows:

1 The Southeast Quarter of the Northwest Quarter; The
 2 Northeast Quarter of the Southwest Quarter; The
 3 Northwest Quarter of the Southeast Quarter; the West
 4 One-Half of the Northeast Quarter of the Southeast
 5 Quarter; The Southwest Quarter of the Southeast
 6 Quarter; EXCEPT the East One-Half of the Southeast
 7 Quarter thereof; The Northwest Quarter of the Southeast
 8 Quarter of the Southeast Quarter; and also, that
 9 portion of the Northeast Quarter of the Southeast
 10 Quarter of the Southeast Quarter described as follows:
 11 Beginning at the Southwest corner of the North One-Half
 12 of the Northeast Quarter of the Southeast Quarter of
 13 the Southeast Quarter, THENCE East along the South line
 14 thereof 150 feet; THENCE North parallel to the West
 15 line thereof to a point 155 feet South of the North
 16 line thereof; THENCE West, parallel to the North line
 17 thereof 120 feet; THENCE North, parallel to the West
 18 line thereof to the North line of said sub; THENCE West
 19 to the Northwest corner of said sub; THENCE South along
 20 the West line thereof to the point of beginning, all in
 21 SECTION 31, TOWNSHIP 23N, RANGE 3E, W.M., King County,
 22 Washington.
