ORDINANCE NO. 4172

AN ORDINANCE approving the water general comprehensive plan for King County Water District No. 49.

PREAMBLE:

King County Water District No. 49 passed Resolution No. 694 adopting the District's Comprehensive Plan, July, 1976 on November 4, 1976.

Water District No. 49 filed a Declaration of Non-Significance on November 4, 1976 for the proposed plan.

The Utilities Technical Review Committee reviewed the proposed plan as required by KCC 13.24, and on October 13, 1977, recommended its approval.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County Water District No. 49 Comprehensive Plan, July, 1976 as adopted by district Resolution 694 (attached) is hereby approved.
