 ORDINANCE NO. 4182

AN ORDINANCE amending Ordinance No. 4026 relating to property reclassification for Sammamish River Park, File No. 105-76-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 4026, APPENDIX A, OVERALL LEGAL DESCRIPTION is hereby amended as follows:

OVERALL LEGAL DESCRIPTION:

That portion of the E 1/2 of the SE 1/4 of Section 9,
Township 26 North, Range 5 East, W.M., lying southerly of a line
825 feet south of the north line of said subdivision and easterly
of the Sammamish River; situate in the County of King, State of
Washington; TOGETHER WITH that portion of the SW 1/4 of the
SW 1/4 of Section 10, Township 26 North, Range 5 East, W.M. in
King County, Washington described as follows: Beginning at the
northwest corner of said SW 1/4 of the SW 1/4 and running thence
N 88°34' E 751.1 feet along the north line of said SW 1/4 of the
SW 1/4; thence S 1°48' E 1309 feet more or less, to the center
of the present channel of Sammamish River. Thence northwesterly
following the center line of the present channel of Sammamish
River 894 feet more or less, to a point on the west line of the
SW 1/4 of the SW 1/4. Thence N 1°53' W 830 feet more or less,
to the Point of Beginning, less the east 316.10' of the north 30',

LESS: That portion lying westerly of a line drawn concentric with the distant 160.00 feet easterly from the center
