

ORDINANCE NO. 4210

AN ORDINANCE relating to the King County Capital Budget and Program, transferring \$15,630 from the Southeast Central Community Allocation to the Tahoma #2 Project Account, and \$11,255 from the Southeast Central Community Allocation to the Levdanski Project Account, and accelerating these programs from the 1980 Capital Improvement Program to the 1979 Capital Improvement Budget, and revising the 1979 Parks Capital Improvement Budget; amending Ordinance No. 3969, Sections 70 and 71, Attachment No. 1, as amended, and amending Ordinance No. 3977, Section 5, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a transfer and acceleration of funds in the amount of \$26,885 from the Southeast Central Community Allocation, Project No. 007074, to the Tahoma #2 Park Project No. 081711 in the amount of \$15,630, and to the Levdanski Park Project No. 070302 in the amount of \$11,255 for the perimeter fencing of both sites.

SECTION 2. Ordinance No. 3969, Section 71, as amended, is hereby amended to read as follows:
