AN ORDINANCE relating to the abandonment of certain Forward Thrust arterial street projects within the City of Auburn and the reallocation of these funds to other projects pursuant to King County Resolution No. 34569, Section 6.

PREAMBLE:

WHEREAS, the City of Auburn has, on February 6, 1978, enacted Resolution No. 854 (hereto attached) determined that the following Forward Thrust arterial street projects contained in King County Resolution No. 34569, Section 3-B, City of Auburn have become impractical to substantially accomplish due to conditions changed by actions of superior governmental authorities

- (2) 1st Street N.E. and N.W. from "A" Street N.W. to "E" Street N.E.
- (8) "A" Street S.W. and N.W. from 3rd Street S.W. to 15th Street N.W.
- (9) "E" Street S.E. from 4th Street S.E. to 4th Street N.E.
- (12) 2nd Street S.W. and S.E. from "A" Street S.W. to "E" Street S.E. and,

WHEREAS, the City of Auburn having determined by Resolution No. 854, Section 5, that all projects which it has been authorized to accomplish pursuant to King County Resolution No. 34569 have been completed, or their completion duly provided for, or their completion found to be impractical, has determined that bond proceeds be applied to carry out the following Public Arterial Highway Facility purposes within the territorial limits of Auburn:

- (17) "A" Street N.W. from Main Street to First Street N.W.
- (18) Division Street from Main Street to First Street N.W.
- (19) Main Street from "A" Street N.W. to Division Street
- (20) First Street N.W. from "A" Street N.W. to Division Street
- (21) E. Main Street from Auburn Way North to "N" Street N.E.

(22) "A" Street S.E. from E. Main to South Auburn City Limits, and,

WHEREAS, Resolution No. 34569, Section 6, requires that the King County Legislative Authority determine that the proposed additional projects are consistent with the purposes of Resolution No. 34569 and are a county purpose, therefore,

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pursuant to Section 6, of Resolution No. 34569, the following projects within the City of Auburn are determined to be consistent with the purposes of the above Resolution and a county purpose:

(17) "A" Street N.W. from Main Street to First Street N.W.

(18) Division Street from Main Street to First Street N.W.

(19) Main Street from "A" Street N.W. to Division Street

(20) First Street N.W. from "A" Street N.W. to Division Street

(21) E Main Street from Auburn Way North to "N" Street N.E.

(22) "A" Street S.E. from E. Main to South Auburn City Limits

SECTION 2. Letter from City of Auburn, Director of Public Works dated April 20, 1979, is attached hereto and made a part of this ordinance.
