ORDINANCE NO. 4234

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of United Investors (Partnership), Building and Land Development Division File No. 263-77-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. United Investors (Partnership) petitioned on July 13, 1977, that the property described in Section 3 below be reclassified from RS 7200 (Potential RM 2400) to RM 2400 and this application was assigned Building and Land Development Division File No. 263-77-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on October 18, 1977, and hearing was held by the Examiner on the matter October 25, 1977. The report of the Examiner was filed with the Clerk of the King County Council on November 17, 1977, and the Council approved the reclassification by Motion No. 03306 on November 21, 1977, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
