8 ORDINANCE NO. 4258

9 AN ORDINANCE amending King County Zoning Resolution  
10 No. 25789, as amended, by amending the Zoning Map  
11 thereof reclassifying certain property thereon at  
the request of Vivian Erwin, Building and Land  
Development Division File No. 242-75-R.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. Vivian Erwin petitioned on May 15, 1975, that the  
14 property described in Section 3 below be reclassified from G to  
15 RS 9600 and this application was assigned Building and Land  
16 Development Division File No. 242-75-R.

17 SECTION 2. The report and recommendation of the Building and  
18 Land Development Division was transmitted to the Zoning and Sub-  
19 Division Examiner on July 15, 1975, and hearing was held by the  
20 Examiner on the matter July 22, 1975. The report of the Examiner  
21 was filed with the Clerk of the King County Council on August 13,  
22 1975, and the Council approved the reclassification by Motion No.  
23 2149 on September 15, 1975.

24 SECTION 3. The legal description of the property to be re-  
25 classified is attached as Appendix A and is hereby made a part of  
26 this ordinance. The above described property is shown on the  
27 attached map which is designated Appendix B and is hereby made a  
28 part of this ordinance.

1 SECTION 4. The King County Council does hereby amend King  
2 County Zoning Code, Resolution No. 25789, as amended, by reclassi-  
3 fying that property described and shown in Section 3, Appendices  
4 A and B above, to RS 9600 and directs that Area Map W 11-21-5 be  
5 modified to so designate.
