10 ORDINANCE NO. 4288

11 AN ORDINANCE amending King County Zoning  
12 Resolution No. 25789, as amended, by amending  
13 the Zoning Map thereof reclassifying certain  
14 property thereon at the request of Travis W.  
15 Brock, et ux., Building and Land Development  
16 Division File No. 435-78-R.

17 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

18 SECTION 1. Travis W. Brock, et ux. petitioned on  
19 September 26, 1978, that the property described in Section 3  
20 below be reclassified from SR (Potential MH) to MH and this  
21 application was assigned Building and Land Development Division  
22 File No. 435-78-R.

23 SECTION 2. The report and recommendation of the Building  
24 and Land Development Division was transmitted to the Zoning  
25 and Subdivision Examiner on December 7, 1978, and hearing was  
26 held by the Examiner on the matter December 14, 1978. The  
27 report of the Examiner was filed with the Clerk of the King  
28 County Council on January 12, 1979, and the Council approved  
29 the reclassification by Motion No. 3971 on January 22, 1979.

30 SECTION 3. The legal description of the property to be re-  
31 classified is attached as Appendix A and is hereby made a part  
of this ordinance. The above described property is shown on the  
attached map which is designated Appendix B and is hereby made

1 a part of this ordinance.

2 SECTION 4. The King County Council does hereby amend King  
3 County Zoning Code, Resolution No. 25789, as amended, by reclassi-  
4 fying that property described and shown in Section 3, Appendices  
5 A and B above, to MH and directs that Area Map W 30-21-5  
6 be modified to so designate.

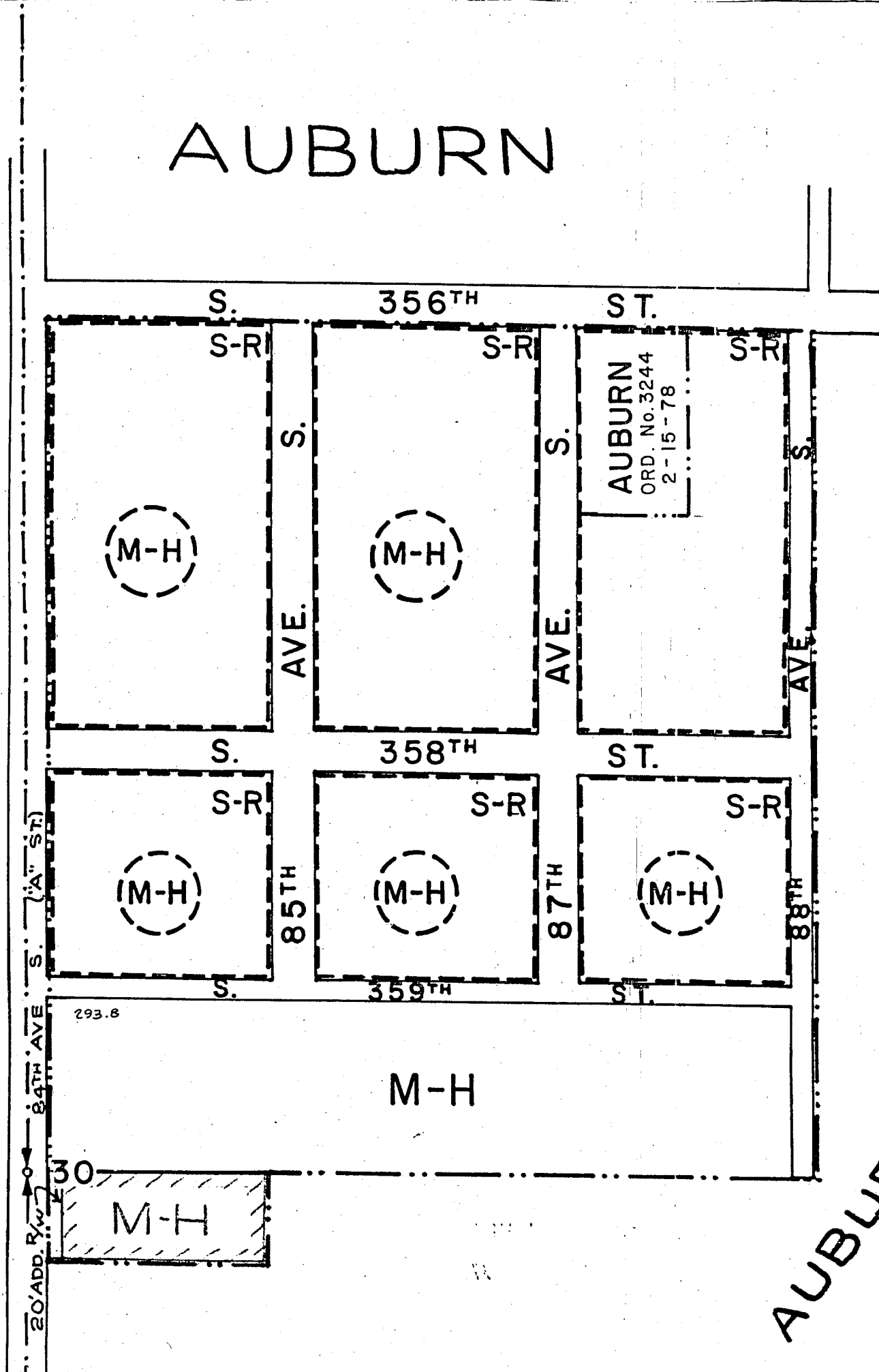
