7 ORDINANCE NO. 4291

8 AN ORDINANCE amending King County Zoning Resolution  
9 No. 25789, as amended, by amending the Zoning Map  
10 thereof reclassifying certain property thereon at  
the request of Hattie H. Hisey, et al, Building and  
Land Development Division File No. 207-79-R.

11 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

12 SECTION 1. Hattie H. Hisey, et al, petitioned on November 6,  
13 1978, that the property described in Section 3 below be reclassified  
14 from BC to RM 900 and this application was assigned Building and  
15 Land Development Division File No. 207-79-R.

16 SECTION 2. The report and recommendation of the Building and  
17 Land Development Division was transmitted to the Zoning and Sub-  
18 division Examiner on January 18, 1979, and hearing was held by the  
19 Examiner on the matter January 25, 1979. The report of the Examiner  
20 was filed with the Clerk of the King County Council on February 21,  
21 1979, and the Council approved the reclassification by Motion No.  
22 4041 on February 26, 1979, subject to conditions which will be  
23 satisfied per the "P" suffix.

24 SECTION 3. The legal description of the property to be re-  
25 classified is attached as Appendix A and is hereby made a part of  
26 this ordinance. The above described property is shown on the at-  
27 tached map which is designated Appendix B and is hereby made a part  
28 of this ordinance.

1        SECTION 4. The King County Council does hereby amend King  
2 County Zoning Code, Resolution No. 25789, as amended by reclassifying  
3 that property described and shown in Section 3, Appendices A  
4 and B above, to RM 900-P and directs that Area Map W 7-23-5 be  
5 modified to so designate.

6        SECTION 5. This reclassification is granted subject to condi-  
7 tions adopted in Motion No. 4041 and said conditions are incorpor-  
8 ated as though fully set forth herein.

9        INTRODUCED AND READ for the first time this 18th  
10 day of December, 19 78.

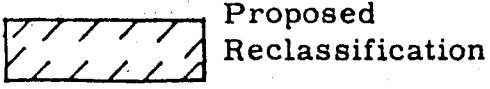
OVERALL LEGAL DESCRIPTION:
