6 ORDINANCE NO. **4295**

7 AN ORDINANCE amending King County Zoning  
8 Resolution No. 25789, as amended, by amending  
9 the Zoning Map thereof reclassifying certain  
property thereon at the request of the Estate  
of Frank C. Trunk, Building and Land Develop-  
ment Division File No. 301-78-R.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. The Estate of Frank C. Trunk petitioned on  
12 August 16, 1978, that the property described in Section 3 below  
13 be reclassified from BC and RS 9600 (Potential RM 2400) to RM 2400  
14 and this application was assigned Building and Land Development  
15 Division File No. 301-78-R.

16 SECTION 2. The report and recommendation of the Building  
17 and Land Development Division was transmitted to the Zoning and  
18 Subdivision Examiner on October 5, 1978, and hearing was held  
19 by the Examiner on the matter October 12, 1978. The report of  
20 the Examiner was filed with the Clerk of the King County Council  
21 on February 8, 1979, and the Council approved the reclassification  
22 by Motion No. 04020 on February 13, 1979, subject to conditions  
23 which will be satisfied per the "P" suffix.

24 SECTION 3. The legal description of the property to be re-  
25 classified is attached as Appendix A and is hereby made a part  
26 of this ordinance. The above described property is shown on the  
27 attached map which is designated Appendix B and is hereby made  
28 a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King  
30 County Zoning Code, Resolution No. 25789, as amended, by reclassi-  
31 fying that property described and shown in Section 3, Appendices

1 A and B above, to RM 2400-P and directs that Area Map E 31-26-5  
2 be modified to so designate.

3 SECTION 5. This reclassification is granted subject to condi-  
4 tions adopted in Motion No. 04020 and said conditions are incor-  
5 porated as though fully set forth herein.
