

ORDINANCE NO. **4299**

2 AN ORDINANCE making an appropriation in  
3 the amount of \$90,000 to the Solid Waste  
4 Capital Fund from Bond Sale proceeds for  
5 a proposed Northshore Transfer Station  
6 project; amending and revising the 1979  
7 Solid Waste Capital Improvement Budget  
8 and Program and amending Ordinance No.  
9 3969, Section 71, Attachment No. 1, as  
10 amended.

11 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY;

12 SECTION 1. There is hereby approved and adopted an appro-  
13 priation in the amount of \$90,000 to the Solid Waste Capital Fund  
14 from Bond Sale proceeds to be used as earnest money for securing  
15 earnest money agreements to purchase two parcels of property for  
16 a proposed Northshore Transfer Station; C.I.P. Project No. 003033.

17 SECTION 2. The earnest money deposits and real property  
18 purchases under the earnest money agreements authorized by  
19 Section 1 of this ordinance shall be made explicitly contingent  
20 upon the granting of an unclassified use permit necessary for  
21 the operation of a solid waste transfer station.

22 SECTION 3. The purpose of this ordinance is to secure  
23 earnest money agreements on real property and does not represent  
24 a decision to approve the site for a transfer station. The  
25 Council recognizes the construction of a transfer station requires  
26 an unclassified use permit and that the property owners have  
27 applied for an unclassified use permit for the Northshore  
28 Transfer Station. A decision thereon shall be made based on  
29 existing standards and procedures, including a Public Hearing by  
30 the Hearing Examiner, governing unclassified use permits. This  
31 ordinance shall not be considered in the review and decision on  
32 the unclassified use permit application.
