8 ORDINANCE NO. 4309

9 AN ORDINANCE amending King County Zoning Resolu-
10 tion No. 25789, as amended, by amending the Zoning
11 Map thereof reclassifying certain property thereon
at the request of Chief Construction, Building and
Land Development Division File No. 281-78-R.

12 BE IT ORDAINED BY THE COUCIL OF KING COUNTY:

13 SECTION 1. Chief Construction petitioned on May 8, 1978, that
14 the property described in Section 3 below be reclassified from
15 RS 7200 to RD 3600 and this application was assigned Building and
16 Land Development Division File No. 281-78-R.

17 SECTION 2. The report and recommendation of the Building and
18 Land Development Division was transmitted to the Zoning and Sub-
19 division Examiner on August 17, 1978, and hearing was held by the
20 Examiner on the matter August 24, 1978 and November 30, 1978. The
21 report of the Examiner was filed with the Clerk of the King County
22 Council on January 19, 1979, and the Council approved the reclassi-
23 fication by Motion No. 03984 on January 29, 1979, subject to condi-
24 tions which will be satisfied per the "P" suffix.

25 SECTION 3. The legal description of the property to be re-
26 classified is attached as Appendix A and is hereby made a part of
27 this ordinance. The above described property is shown on the
28 attached map which is designated Appendix B and is hereby made a
29 part of this ordinance.

1 SECTION 4. The King County Council does hereby amend King
2 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
3 fying that property described and shown in Section 3, Appendices
4 A and B above, to RD 3600-P and directs that Area Map E 8-21-4 be
5 modified to so designate.

6 SECTION 5. This reclassification is granted subject to condi-
7 tions adopted in Motion No. 03984 and said conditions are incorpor-
8 ated herein as though fully set forth herein.
