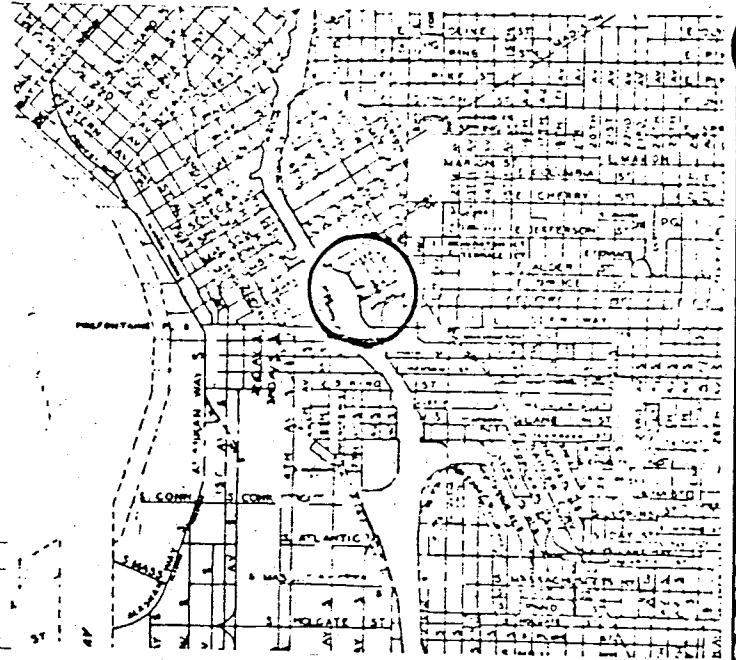

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The amount of \$115,000 is hereby appropriated to the Grant Fund from the Municipality of Metropolitan Seattle Project P.000148010 for Improvement of Surface Water Management, Grant File No. 916.

SECTION 2. The County Council hereby acknowledges a required in-kind match of \$38,334 by King County in support of Improvement of Surface Water Management.
