

ORDINANCE NO. 4367

AN ORDINANCE relating to the annexation of an area known as DS-9 to Des Moines Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as DS-9 to Des Moines Sewer District was filed with the County Council effective May 25, 1979.

2. Des Moines Sewer District has found the petition for annexation to be sufficient and has, by Resolution 79-19, concurred with the proposed annexation.

3. Des Moines Sewer District filed a Declaration of Nonsignificant Impact dated May 9, 1979, on the proposed annexation.

4. The County Council held a public hearing on the 9th day of July, 1979, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Des Moines Sewer District of the area known as DS-9 and described in Section 2 herein is approved.

SECTION 2. The area known as DS-9 to be annexed is described as follows:

Beginning at the West ¼ corner of Section 8, Township 22 North, Range 4 East, W.M., King County, Washington;

Thence North 8°09'59" West 20.20 feet on the West line of said Section to the intersection of said West line and the Westerly extension of the South line of Blocks 1 and 2 in the Plat of the Southern Pacific Land Co. 2nd Add. to Des Moines as recorded in Volume 4 of Plats, page 49, records of King County, Washington;

Thence Easterly along said extended line to the West margin of Marine View Drive;

Thence Northerly along said West margin to its intersection with said West line of Section 8;

Thence North 8°09'59" West along said West line, known also as the centerline of 1st Avenue S., to its intersection with the centerline of South 212th St.;

1 Thence Easterly along the centerline of said S. 212th
2 St. to its intersection with the Northerly extension of
3 the centerline of the alley located between 6th Ave. S.
4 and 5th Ave. S.;

5 Thence Southerly along said centerline to its
6 intersection with the centerline of S. 214th St.;

7 Thence West along said centerline of S. 214th St. to
8 its intersection with the Northerly extension of the
9 centerline of the alley located between 4th Pl. S. and
10 4th Ave. S.;

11 Thence Southerly along said centerline to its
12 intersection with the East-West centerline of said
13 Section 8;

14 Thence Westerly along said East-West centerline, known
15 as the centerline of South 216th St., to the Point of
16 Beginning.
