ORDINANCE NO. 4380

AN ORDINANCE approving Additions and Betterments to the Water District 125 Comprehensive Plan.

PREAMBLE:

Water District No. 125 passed Resolution No. 781101-28 on November 1, 1978 and Resolution No. 79314-36 on March 14, 1979 which provided for additions and betterments to their Comprehensive Plan.

The additions and betterments approved by Resolution No. 781101-28 are exempt from the requirements of the State Environmental Policy Act. King County filed a Declaration of Non-Significance for the proposed development to be served by the additions and betterments approved by Resolution No. 79314-36 on April 7, 1978.

The Utilities Technical Review Committee reviewed the proposed additions and betterments as required by KCC 13.24 and on June 13, 1979 recommended their approval.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Executive Estates and Valley View Complex additions and betterments to the Water District 125 Comprehensive Plan as adopted by district Resolution Nos. 781101-28 and 79314-36 (attached) are each hereby approved.
