8 ORDINANCE NO. **4398**

9 AN ORDINANCE amending King County Zoning Resolution  
10 No. 25789, as amended, by amending the Zoning Map  
11 thereof reclassifying certain property thereon at  
the request of Eileen Williams, Building and Land  
Development Division File No. 107-79-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Eileen Williams petitioned on October 23, 1978,  
15 that the property described in Section 3 below be reclassified  
16 from RS 9600 to RM 1800 and this application was assigned Build-  
17 ing and Land Development Division File No. 107-79-R.

18 SECTION 2. The report and recommendation of the Building and  
19 Land Development Division was transmitted to the Zoning and Sub-  
20 division Examiner on February 1, 1979, and hearing was held by the  
21 Examiner on the matter February 8, 1979. The report of the Examiner  
22 was filed with the Clerk of the King County Council on March 9,  
23 1979, and the Council approved the reclassification by Motion  
24 No. 4090 on March 19, 1979.

25 SECTION 3. The legal description of the property to be re-  
26 classified is attached as Appendix A and is hereby made a part  
27 of this ordinance. The above described property is shown on the  
28 attached map which is designated Appendix B and is hereby made  
29 a part of this ordinance.

30 SECTION 4. The King County Council does hereby amend King  
31

County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RM 1800 and directs that Area Map E 30-26-5 be modified to so designate.
