5 AN ORDINANCE relating to the abandonment
6 of certain Forward Thrust arterial street
7 projects within the City of Mercer Island
8 and the reallocation of these funds to
9 other projects pursuant to King County
10 Resolution No. 34569, Section 6.

11 PREAMBLE:

12 The City of Mercer Island has, on September 26, 1977,
13 enacted Ordinance No. 436 (hereto attached) and determined that
14 the following Forward Thrust arterial street projects contained
15 in King County Resolution No. 34569, Section 3, City of Mercer
16 Island, have become impractical to substantially accomplish:

- 17 S (3) 78th Avenue S.E. - S.E. 34th Street to
18 West Mercer Way (duly provided for from
19 S.E. 34th Street to S.E. 40th Street -
20 from S.E. 40th Street to West Mercer
21 Way no longer classified as arterial)
- 22 (14) S.E. 72nd Street - West Mercer Way to
23 84th Avenue S.E.
- 24 (16) Island Crest Way - S.E. 68th Street to
25 80th Avenue S.E.
- 26 S (4) North Mercer Way - 88th Avenue S.E. to
27 90th Avenue S.E.
- 28 (5) 84th Avenue S.E. - S.E. 24th Street to
29 North Mercer Way
- 30 (7) North Mercer Way - West Mercer Way to
31 S.E. 22nd Street
- 32 (8) West Mercer Way - I-90 to North Mercer
33 Way
- T (9) 76th Avenue S.E. from S.E. 24th Street
to S.E. 22nd Street
- (10) S.E. 22nd Street from North Mercer Way
to 86th Avenue S.E.

34 The City of Mercer Island, having determined by
35 Ordinance No. 436, Sections 1 and 2, that all projects which it
36 has been authorized to accomplish pursuant to King County
37

1 Resolution No. 34569 have been completed, or their completion.
2 duly provided for, or their completion found to be impractical,
3 has determined that bond proceeds be applied to carry out the
4 following new public arterial highway improvements within the
5 territorial limits of Mercer Island:

- 6 (1) S.E. 40th Street - Island Crest Way to
7 92nd Avenue S.E.
- 8 (2) 76th Avenue S.E. - S.E. 24th Street to
9 S.E. 28th Street
- 10 (3) S.E. 27th Street - 76th Avenue S.E. to
11 78th Avenue S.E.
- 12 (4) 78th Avenue S.E. - S.E. 27th Street to
13 S.E. 34th Street
- 14 (5) S.E. 28th Street - 78th Avenue S.E. to
15 Island Crest Way
- 16 (6) S.E. 32nd Street - 77th Avenue S.E. to
17 78th Avenue S.E.
- 18 (7) 77th Avenue S.E. - Sunset Highway to
19 S.E. 32nd Street
- 20 (8) S.E. 29th Street - 76th Avenue S.E. to
21 78th Avenue S.E.
- 22 (9) North Mercer Way - 76th Avenue S.E. to
23 S.E. 27th Street.

24 Resolution No. 34569, Section 6, requires that the
25 King County Legislative Authority determine that the proposed
26 additional projects are consistent with the purposes of Resolution
27 No. 34569, that is, arterial highway improvements, and are a
28 County purpose.

29 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

30 SECTION 1. Pursuant to Section 6 of Resolution No.
31 34569, the following projects within the City of Mercer Island
32 are determined to be consistent with the purposes of the above
33 Resolution No. 34569 and a County purpose:

- (1) S.E. 40th Street - Island Crest Way to
92nd Avenue S.E.




