ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Modulaire Leasing Company, Building and Land Development Division File No. 220-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Modulaire Leasing Company petitioned on December 26, 1978, that the property described in Section 3 below be reclassified from CG and RM 1800 to CG and this application was assigned Building and Land Development Division File No. 220-79-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on February 15, 1979, and hearing was held by the Examiner on the matter February 22, 1979. The report of the Examiner was filed with the Clerk of the King County Council on May 31, 1979, and the Council approved the reclassification by Motion No. 4288 on June 4, 1979.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended,

1 by reclassifying that property described and shown in  
2 Section 3, Appendices A and B above, to CG and directs that  
3 Area Map E 9-22-4 be modified to so designate.

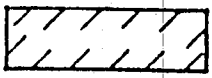
