12 AN ORDINANCE amending King County Zoning Resolu-  
13 tion No. 25789, as amended, by amending the Zoning  
14 Map thereof reclassifying certain property thereon  
at the request of Gerald Plith, Building and Land  
Development Division File No. 244-79-R:

15 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16 SECTION 1. Gerald Plith petitioned on March 6, 1979,  
17 that the property described in Section 3 below be reclassified  
18 from RS 7200 (Potential RM 1800) to RM 1800 and this application  
19 was assigned Building and Land Development Division File No.  
20 244-79-R.

21 SECTION 2. The report and recommendation of the Building  
22 and Land Development Division was transmitted to the Zoning  
23 and Subdivision Examiner on May 24, 1979, and hearing was held  
24 by the Examiner on the matter May 31, 1979. The report of the  
25 Examiner was filed with the Clerk of the King County Council  
26 on July 26, 1979, and the Council approved the reclassification  
27 by Motion No. 4401 on July 30, 1979, subject to conditions which  
28 will be satisfied per the "P" suffix.

29 SECTION 3. The legal description of the property to be  
30 reclassified is attached as Appendix A and is hereby made a  
31 part of this ordinance. The above described property is  
32 shown on the attached map which is designated Appendix B and  
33 is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RM 1800-P and directs that Area Map W 22-23-4 be modified to so designate.

SECTION 5. This reclassification is granted subject to conditions adopted in Motion No. 4401 and said conditions are incorporated herein as though fully set forth herein.
