8 ORDINANCE NO. 4888

9 AN ORDINANCE amending King County Zoning Resolution
10 No. 25789, as amended, by amending the Zoning Map
11 thereof reclassifying certain property thereon at
12 the request of Wayne E. Cornett, Building and Land
13 Development Division File No. 150-79-R.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. Wayne E. Cornett petitioned on March 21, 1979, that
16 the property described in Section 3 below be reclassified from G
17 (POTENTIAL M-L) to M-L and this application was assigned Building
18 and Land Development Division File No. 150-79-R.

19 SECTION 2. The report and recommendation of the Building and
20 Land Development Division was transmitted to the Zoning & Subdivi-
21 sion Examiner on June 8, 1979, and hearing was held by the Examiner
22 on the matter June 14, 1979. The report of the Examiner was filed
23 with the Clerk of the King County Council on August 9, 1979, and
24 the Council approved the reclassification by Motion No. 4434 on
25 August 13, 1979, subject to conditions which will be satisfied per
26 the "P" suffix.

27 SECTION 3. The legal description of the property to be
28 reclassified is attached as Appendix A and is hereby made a part
29 of this ordinance. The above described property is shown on the
30 attached map which is designated Appendix B and is hereby made a
31 part of this ordinance.

32 SECTION 4. The King County Council does hereby amend King
33 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
fying that property described and shown in Section 3, Appendices A

1 and B above, to M-P-P and directs that Area Map W 5-22-3 be modified
2 to so designate.

3 SECTION 5. This reclassification is granted subject to
4 conditions adopted in Motion No. 4434 and said conditions are
5 incorporated herein as though fully set forth herein.


