

ORDINANCE NO. 4907

AN ORDINANCE relating to the annexation of an area known as DS-59 to Des Moines Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as DS-59 to Des Moines Sewer District was filed with the County Council, April 23, 1980.

2. Des Moines Sewer District has found the petition for annexation to be sufficient and has, by Resolution 1980-9 concurred with the proposed annexation.

3. Des Moines Sewer District filed a Declaration of Nonsignificant impact dated April 9, 1980, on the proposed annexation.

4. The County Council held a public hearing on the 2nd day of June, 1980, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1, The annexation by Des Moines Sewer District of the area known as DS-59 and described in Section 3 herein is approved.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

SECTION 3. The area known as DS-59 to be annexed is described as follows:

Beginning at the intersection of the East line of Section 8, Township 22 North, Range 4 East, W.M., with the centerline of S. 216th Street;

Thence, westerly along said centerline to its intersection with the West line of the East 572.6 feet of the Northeast quarter of the Northeast quarter of the Southeast quarter of said Section 8;

Thence, southerly along said West line to its intersection with the South line of the North half of the Northeast quarter of the Southeast quarter of said Section 8;

Thence, easterly along said South line to its intersection with the East line of said Section 8;

Thence, southerly along said East line to its intersection with the Westerly margin of SR 509, MP 19.43 to MP 23.87, SR 516 to Des Moines Way South, approve 12-1-69, sheets 4 and 5 of 22;

Thence, northerly and westerly along said Westerly margin of SR 509 to its intersection with the East line of said Section 8;

Thence, northerly along said East line to its intersection with the centerline of S. 216th Street and the Point of Beginning.
