AN ORDINANCE relating to Animal Control; establishing a dog control zone in the Wilderness Rim Community; amending KCC 11.08.170, and Ordinance No. 4385.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. KCC 11.08.170 and Ordinance 4385 are amended to read as follows:

Dog Control Zone - Wilderness Rim Community. Under the provisions of this chapter, there is created a dog control zone in the following described area:

~~((PROVIDED THAT, unless re-enacted by ordinance, unlawful acts, violations and penalties as specified in this act shall not have the force of law after January 31, 1980;~~

~~PROVIDED THAT, actions pursuant to any provisions of this act, begun prior to January 31, 1980, shall not be affected by expiration of this act.))~~
