ORDINANCE NO. 4931

AN ORDINANCE relating to the annexation of an area known as 46th Avenue South to Val Vue Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as 46th Avenue South to Val Vue Sewer District was filed with the County Council April 28, 1980.
- 2. Val Vue Sewer District has found the petition for annexation to be sufficient and has, by Resolution 876 concurred with the proposed annexation.
- 3. Val Vue Sewer District filed a Declaration of Nonsignificant Impact dated April 2, 1980, on the proposed annexation.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Val Vue Sewer District of the area known as 46th Avenue South and described in Section 3 is approved.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

SECTION 3. The area known as 46th Avenue South to be annexed is described as follows:

THAT PORTION OF THE NORTHEAST QUARTER OF SECTION 22, TOWNSHIP 23 NORTH, RANGE 4 EAST, W.M. IN KING COUNTY, WASHINGTON DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE CENTERLINE OF SOUTH 144th STREET AND THE NORTHERLY EXTENSION OF THE WEST LINE OF LOT 8, BLOCK 3, ADAMS HOME TRACTS AS RECORDED IN VOLUME 11 OF PLATS, PAGE 31, RECORDS OF KING COUNTY, WASHINGTON: THENCE EASTERLY ALONG THE CENTER LINE OF SOUTH 144th STREET TO THE NORTHERLY EXTENSION OF THE EAST LINE OF LOT 2, BLOCK 4 of said ADAMS HOME TRACTS: THENCE SOUTH ALONG SAID NORTHERLY EXTENSION AND ALONG THE EAST LINE OF SAID LOT 2 TO THE SOUTHEAST CORNER THEREOF: THENCE WEST ALONG THE SOUTH LINE OF SAID LOT 2 TO THE NORTHEAST CORNER OF LOT 20 IN SAID BLOCK 4; THENCE SOUTH ALONG THE EAST LINE OF SAID LOT 20 TO THE SOUTHEAST CORNER THEREOF: THENCE SOUTHERLY TO THE NORTHWEST CORNER OF LOT 2, BLOCK 5 OF THE SAID ADAMS HOME TRACTS:

THENCE SOUTHERLY ALONG THE WEST LINE OF SAID LOT 2 TO THE SOUTH LINE OF THE NORTH 140 FEET THEREOF: THENCE EAST ALONG SAID SOUTH LINE TO THE EAST LINE OF SAID LOT 2; THENCE SOUTH ALONG SAID EAST LINE TO THE SOUTHEAST CORNER OF SAID LOT 2; THENCE WEST ALONG SAID SOUTH LINE TO THE NORTHEAST CORNER OF LOT 20 IN SAID BLOCK 5; THENCE SOUTH ALONG THE EAST LINE OF SAID LOT 20 TO THE SOUTHEAST CORNER THEREOF: THENCE SOUTHERLY TO THE NORTHEAST CORNER OF LOT 1, BLOCK 2, SECOND ADDITION TO ADAMS' HOME TRACTS AS RECORDED IN VOLUME 12 OF PLATS, PAGE 90, RECORDS OF KING COUNTY, WASHINGTON:

THENCE SOUTH ALONG THE EAST LINE OF SAID LOT 1 TO THE SOUTHEAST CORNER THEREOF: THENCE WEST ALONG THE SOUTH LINE OF SAID LOT 1 TO THE SOUTHWEST CORNER THEREOF: THENCE WESTERLY TO THE SOUTHEAST CORNER OF LOT 10, BLOCK 1 IN SAID SECOND ADDITION TO ADAMS' HOME TRACTS: THENCE WEST ALONG THE SOUTH LINE OF SAID LOT 10 TO THE SOUTHWEST CORNER THEREOF: THENCE NORTH ALONG THE WEST LINE OF SAID LOT 10 AND ALONG THE NORTHERLY EXTENSION THEREOF TO THE CENTERLINE OF SOUTH 148TH STREET: THENCE WEST ALONG SAID CENTERLINE TO THE SOUTHERLY EXTENSION OF THE WEST LINE OF LOT 12, BLOCK 6, ADAMS HOME TRACTS AS RECORDED IN VOLUME 11 OF PLATS, PAGE 31, RECORDS OF KING COUNTY, WASHINGTON: THENCE NORTHERLY ALONG SAID SOUTHERLY EXTENSION AND ALONG THE WEST LINE OF SAID LOT 12 AND ALONG THE EAST LINE OF LOT 8 IN SAID BLOCK 6 TO THE SOUTH LINE OF THE NORTH 145 FEET OF SAID LOT 8;

THENCE WEST ALONG SAID SOUTH LINE TO THE WEST LINE OF THE EAST 91 FEET OF SAID LOT 8; THENCE NORTH ALONG SAID WEST LINE AND ALONG THE NORTHERLY EXTENSION OF SAID WEST LINE TO THE CENTERLINE OF SOUTH 146TH STREET: THENCE WEST ALONG SAID CENTERLINE TO THE SOUTHERLY EXTENSION OF THE WEST LINE OF LOT 13, BLOCK 3 of SAID ADAMS HOME TRACTS: THENCE NORTHERLY ALONG SAID SOUTHERLY EXTENSION AND ALONG THE WEST LINE OF SAID LOT 13 TO THE NORTHWEST CORNER THEREOF: THENCE NORTHERLY ALONG THE WEST LINE OF LOT 8 IN SAID BLOCK 3 AND ALONG THE NORTHERLY EXTENSION THEREOF TO THE CENTERLINE OF SOUTH 144TH
