8 ORDINANCE NO. 5078

9 AN ORDINANCE amending King County Zoning Resolution
10 No. 25789, as amended, by amending the Zoning Map,
11 thereof reclassifying certain property thereon at
the request of KITTY ENDERT, Building and Land
Development Division File No. 404-79-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. KITTY ENDERT petitioned on October 9, 1979, that
15 the property described in Section 3 below be reclassified from
16 RS-7200 and RS-7200 (Potential RM-2400) to RM-1800, and this appli-
17 cation was assigned Building and Land Development Division File
18 No. 404-79-R.

19 SECTION 2. The report and recommendation of the Building and
20 Land Development Division was transmitted to the Zoning & Subdivi-
21 sion Examiner on December 6, 1979, and hearing was held by the
22 Examiner on the matter December 13, 1979. The report of the Exam-
23 iner was filed with the Clerk of the King County Council on
24 January 15, 1980, and the Council approved the reclassification by
25 Motion No. 4704 on January 21, 1980, subject to conditions which
26 will be satisfied per the "P" suffix.

27 SECTION 3. The legal description of the property to be
28 reclassified is attached as Appendix A and is hereby made a part of
29 this ordinance. The above described property is shown on the
attached map which is designated Appendix B and is hereby made a
31 part of this ordinance.

32 SECTION 4. The King County Council does hereby amend King
33 County Zoning Code, Resolution No. 25789, as amended, by reclassi-

1 fying that property described and shown in Section 3, Appendices A
2 and B above, to RM-2400-P and directs that Area Map W 22-23-4 be
3 modified to so designate.

4 SECTION 5. This reclassification is granted subject to
5 conditions adopted in Motion No. 4704 and said conditions are
6 incorporated herein as though fully set forth herein.

8 of November 1979.
