ORDINANCE NO. _____

AN ORDINANCE relating to fees charged for the use of King County Parks and Recreation Facilities, and repealing Ordinance No. 4607 and K.C.C. 7.10.010, and repealing Ordinance No. 1800 and K.C.C. 7.08.030 and substituting a new section.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 4607 and K.C.C. 7.10.010 and Ordinance No. 1800 and K.C.C. 7.08.030 are each repealed and the following substituted:

SECTION 2. All persons using King County owned and operated park and recreation facilities shall pay the service fees, which include taxes, where applicable, set forth in the following schedules, effective January 1, 1981:

A. SWIMMING POOL FACILITIES

1. SWIMMING POOL FEES:

- a. Public Swims 50¢ per person per session
- b. Fifteen Cent Swims 15¢ per person per session
- c. Adult Only Swims \$1.00 per person per session
- d. Senior Citizens-60 yrs. plus 50¢ per person for any program session

30 b. Group B - Activity Centers and Community Centers:

31 For any organizations, groups, and clubs, using an Activity
 32 Center during non-program hours, OR, a Community Center at

any time during the day or evening the following FEE SCHEDULE will be applied:

- Basic Opening and Closing Fee \$10.00
- Gymnasium Fee \$10.00 per hour
- Meeting Room Fee \$ 6.00 per hour
- Kitchen Use Fee \$ 6.00

c. Group C - Gold Creek Building Use Fee:

Any group using the building for less than one day, will use the GROUP B fee schedule. Any group using the building for 24 hours or more will use the following fee schedule

- Youth Groups \$25.00 per day
- Adult Groups \$40.00 per day
- Plus one time kitchen use fee \$ 6.00

D. CAMPING FEE

- a. Camping Fee per site \$ 3.50 per day
- b. Shower Fee \$ 0.25¢ per shower

E. PEA PATCH PROGRAM

- a. Pea Patch Rental Per Season \$15.00 per plot
