

ORDINANCE NO. 5339

1 AN ORDINANCE relating to the annexation of an  
2 area known as "Commercial, 1979" to Lakehaven  
3 Sewer District.

4 STATEMENT OF FACT:

5 1. A notice of intention proposing the annexation of an area  
6 known as "Commercial, 1979" to Lakehaven Sewer District was filed  
7 with the County Council January 23, 1981.

8 2. Lakehaven Sewer District has found the petition for  
9 annexation to be sufficient and has, by Resolution 80-811 concurred  
10 with the proposed annexation.

11 3. Lakehaven Sewer District filed a Declaration of Non-  
12 significant Impact dated November 19, 1980, on the proposed  
13 annexation.

14 4. The County Council held a public hearing on the 17th day  
15 of February, 1981, and has considered the criteria set forth in  
16 RCW 56.02.060.

17 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

18 SECTION 1. The annexation by Lakehaven Sewer District of  
19 the area known as "Commercial, 1979" and described in Section 3  
20 herein is approved with the modification recommended in King County  
21 Council's Annexation Report on "Commercial, 1979" which is attached  
22 and made a part of this ordinance.

23 SECTION 2. Completion of this annexation does not constitute  
24 county approval or disapproval of any other permits, certifica-  
25 tions, or actions necessary to provide service to this annexation  
26 area.

27 SECTION 3. The area known as "Commercial, 1979" to be annexed  
28 is described as follows:

1 Those portions of Sections 20, 21, 28 and 29, Township  
2 21 North, Range 4 East, W.M., in King County, Washington  
described as follows:

3 The South half of the Southeast quarter of said Section 20  
4 lying South of the centerline of Primary State Highway  
No. 2 (SR18);

5 TOGETHER WITH the Southwest quarter of the Southwest  
6 quarter of said Section 21 lying South of the centerline  
of Primary State Highway No. 2 (SR 18);

7 TOGETHER WITH the West half of the Northwest quarter of  
8 said Section 28;

9 TOGETHER WITH the North half of the Northeast quarter of  
Section 29;

10 TOGETHER WITH that portion of the South half of the  
11 Northeast quarter of Section 29 lying East of the  
centerline of Pacific Highway South and North of the  
12 centerline of South 359th Street.
