

ORDINANCE NO. 5545

AN ORDINANCE making an appropriation in the amount of \$59,000 to the County Road Construction Fund for construction on 11th Avenue N.E. Drainage in the amount of \$4,000 from a transfer from the Community Block Grant Fund, and for the 16th Avenue South Bridge in the amount of \$55,000 from the County Road Fund; making an appropriation to the Arterial Highway Development Fund in the amount of \$60,000 for construction on 4th Avenue S.W. from a payment from METRO; amending Ordinance No. 5232, Section 73, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation in the amount of \$59,000 to the County Road Construction Fund for additional drainage construction on 11th Avenue N.E. - Drainage, C.I.P. Project No. 100779, from a contribution from the Community Development Block Grant Fund in the amount of \$4,000; and to provide for reconstruction activities on the 16th Avenue South Bridge, C.I.P. Project No. 600379, from a transfer from the County Road Fund in the amount of \$55,000.

SECTION 2. There is hereby approved and adopted an appropriation of \$60,000 to the Arterial Highway Development Fund for the construction of a pedestrian crossing on 4th Avenue S.W., C.I.P. Project No. 601172, from a payment from METRO.

SECTION 3. There is hereby approved and adopted an appropriation of \$55,000 from the unencumbered fund balance of the County Road Fund to "Transfer to Fund 386", C.I.P. Project No. 999977 for 16th Avenue South Bridge.

SECTION 4. Ordinance No. 5232, Section 73, as amended, is hereby amended to read as follows:

The Executive Proposed Capital Budget and Program for 1981 - 1986 is incorporated herein as Attachment No. 1 to this ordinance with the following specified amendments, provisos, and modifications. From the several Capital Improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified and contained in

2 County Road Construction (~~(\$4,144,747)~~) \$4,203,747

3 County Road (CIP Only) (~~(\$3,142,572)~~) \$3,197,572

4 Arterial Highway Development (~~(\$1,882,419)~~) \$1,942,419


6 All provisos adopted by the Council in Ordinance No. 5232,


