

ORDINANCE NO. 5582

AN ORDINANCE relating to the annexation of an area known as Nelson to King County Water District No. 90; amending Ordinance No. 4550 Section 2.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 4550, Section 2 is amended to read as follows:

The area known as Nelson to be annexed is described as follows:

Beginning at the Northwest corner of the East 1/2 of the West 1/2 of the West 1/2 of the NW 1/4 of Section 2, Township 23 North, Range 5 East, W.M.;

Thence Easterly along the North line of the said NW 1/4 to the Northeast corner thereof;

Thence Southerly along the East line of the said NW 1/4 to its intersection with centerline of the New Castle Hobart County Road right of way;

Thence Southeasterly along said centerline to its intersection with a line which bears North 39°00'45" East from a point on the Northeasterly boundary of Block "C", of May Valley Division No. 2, according to plat thereof recorded in Volume 38 of Plats, page 47, records of King County, Washington; said point being South 55°07'36" East 327.07 feet from the most Northerly corner of Lot 12, Block "C";

Thence South 39°00'45" West to the said Northeasterly boundary of Block "C";

Thence North 55°07'36" West along said Northeasterly boundary to its intersection with the North line of the South 1/2 of the South 1/2 of said Section 2;

Thence Westerly along said North line to its intersection with the Northeasterly boundary of Lots 8 and 9, said Block "C";

Thence Westerly along said South line to its intersection with the West line of the East 1/2 of the West 1/2 of the West 1/2 of the said NW 1/4

Thence Northerly along said West line to its intersection with the North line of the said NW 1/4 and the Point of Beginning.


