

ORDINANCE NO. 5783

AN ORDINANCE relating to fees charged for the use of King County Parks and Recreation Facilities, and amending Ordinance No. 5225 and K.C.C. 7.08.010 through 7.08.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 5225 and K.C.C. 7.08.010 are amended to read as follows:

All persons using King County owned and operated park and recreation facilities shall pay the service fees, which include taxes, where applicable, set forth in the following schedules, effective January 1, (~~1981~~) 1982.
