AN ORDINANCE concurring with the recommendation of the Zoning and Subdivision Examiner to approve subject to conditions (modified) the Preliminary Plat of SUNRISE DIVISIONS 2, 3, 4, & 5 designated Building and Land Development File No. 182-7.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

This Ordinance does hereby adopt and incorporate herein the findings and conclusions contained in the report of the Zoning and Subdivision Examiner dated January 6th, 1982, which was filed with the Clerk of the Council on January 21, 1982, to approve subject to conditions (modified) the Preliminary Plat of SUNRISE DIVISIONS 2, 3, 4, & 5, designated by the Building and Land Development Division, Department of Planning and Community Development, File No. 182-7, and the Council does hereby adopt as its action the recommendation (s) contained in said report, with the following modification:

The question of whether the cul de sacs and barriers required by conditions numbers 12 and 20 shall be temporary or permanent shall be determined by the Subdivision Technical Committee after the transportation element of the Northshore Communities Plan has been received and considered by the King County Council.
