## ORDINANCE NO. 6070

AN ORDINANCE relating to zoning, amending the definition of lot area and dimensions five acres and twenty acres; and amending Resolution 25789, Section 276, Ordinance 4303, Section 10, Ordinance 4306, Section 14, and KCC 21.04.410, KCC 21.04.308 and KCC 21.04.663.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Resolution 25789, Section 276 and KCC 21.04.410 are hereby amended to read as follows: Lot area and dimensions.

- A. Lot Area. "Lot area" means the total horizontal area within the boundary lines of a lot including, in addition, up to fifty feet but not more than one-half of the right-of-way of any perimeter public or private street whenever the total area exceeds two acres, provided that such right-of-way shall not comprise more than thirty percent of the required lot area of the zone.
- B. Lot Depth. "Lot depth" means the horizontal length of a straight line drawn from the midpoint of the lot front line and at right angles to such line to its intersection with a line parallel to the lot front line and passing through the midpoint of the rear lot line. In the case of a lot having a curved frontline, the lot front line, for purposes of this section shall be deemed to be a line tangent to the curve and parallel to a straight line connecting the points of intersection of the lot side lines of the lot with the front line.
- C. Lot Width. "Lot width" means the horizontal distance between the lot side lines measured at right angles to the line comprising the depth of the lot at a point midway between the lot front line and the lot rear line.

SECTION 2. Ordinance 4303, Section 10 and KCC 21.04.308 are hereby amended to read as follows:

Five acres. "Five acres" means five acres or one one-hundred-twenty-eighth of the section in which the property is located. ((Up-te-thirty-feet,-but-ne-mere-than-ene-half,-ef-the-right-of-way-of-any-perimeter-public-street-may-be-
