ORDINANCE NO. 6093

AN ORDINANCE appropriating \$42,223 from Executive Contingency in the Current Expense Fund to the Superior Court to provide for 1982 salary increases to court bailiffs; amending Ordinance No. 5757, Section 27, and Section 36, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$42,223 from Executive Contingency in the Current Expense Fund balance for the purpose of funding salary increases to Superior Court bailiffs.

SECTION 2. Ordinance No. 5757, Section, 27, is hereby amended to read as follows:

SECTION 3. Ordinance No. 5757, Section 36, as amended, is hereby amended to read as follows:
