

ORDINANCE NO. 6133

AN ORDINANCE making an appropriation of \$165,000 to the County Road Construction Fund from the unappropriated fund balance of the County Road Fund for cleanup costs of the Sahallee Way N.E.-Slide; amending Ordinance No. 5757, Section 70, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$165,000 to the County Road Construction Fund for cleanup costs of the Sahallee Way N.E.-Slide, Capital Improvement Project No. 400382, from a transfer from the County Road Fund.

SECTION 2. There is hereby approved and adopted an appropriation of \$165,000 from the unencumbered fund balance of the County Road Fund to "Transfer to Fund 386", Capital Improvement Project No. 999977 for Sahallee Way N.E.-Slide.

SECTION 3. Ordinance No. 5757, Section 70, as amended, is hereby amended to read as follows:

From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified and contained in Attachment No. 1 of this ordinance as amended and modified herein.

County Roads (CIP Only)	( <del>\$2,828,679</del> )	<u>\$2,993,679</u>
County Road Construction	( <del>\$4,701,244</del> )	<u>\$4,183,244</u>

All provisos adopted by the Council in Ordinance No. 5757, as amended, shall be fulfilled.
