

ORDINANCE NO. 6140

AN ORDINANCE relating to the annexation of an area known as Annexation Petition No. P-293 to Cascade Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Annexation Petition No. P-293 to Cascade Sewer District was filed with the County Council effective July 30, 1982.

2. Cascade Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 1675 concurred with the proposed annexation.

3. Cascade Sewer District filed a Declaration of Non-significant Impact dated March 4, 1982, on the proposed annexation.

4. The County Council held a public hearing on the 20th day of September, 19 82, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade Sewer District of the area known as Annexation Petition No. P-293 and described in Section 3 herein is approved, subject to the limitations set forth in Section 4 of this ordinance. King County Council Annexation Report on Annexation Petition No. P-293 is attached and made a part of this ordinance.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

SECTION 3. The area known as Annexation Petition No. P-293 to be annexed is described as follows:

Beginning at the Northeast corner of the Northwest quarter of Section 10, Township 22 North, Range 5 East, W.M., in King County, Washington;

Thence Southerly along the East line of said Northwest quarter to the North line of the South 660.00 feet of the Southeast quarter of the Northwest quarter of said Section;

Thence Westerly along the said North line to the East line of the West 491.00 feet of the Southeast quarter of the Northwest quarter of the said Section 10;

Thence Northerly along said East line to the North line of the Southeast quarter of the Northwest quarter of said Section 10;

Thence Easterly along said North line to the West line of the East one half of the Northeast quarter of the Northwest quarter of said Section 10;

Thence Northerly along said West line to the North line of the Northwest quarter of said Section 10;

Thence Easterly along North line to the Point of Beginning.

SECTION 4. This approval of annexation does not constitute approval of any sewer service extension to any of the properties described in Section 3 of this ordinance. Sewer service shall not be authorized unless the properties are included in a Local Service Area. Sewer service shall not be provided unless it can be demonstrated that the properties can be developed consistent with County land development limitations, standards, or policies relating to seismic hazard areas, erosion hazard areas, wetlands or flood plains, the Soos Creek Community Plan, or any other adopted County plans or policies.
