

This Ordinance does hereby adopt and incorporate herein the findings and conclusions contained the report of the Zoning and Subdivision Examiner dated March 23, 1983 which was filed with the Clerk of the Council on April 7, 1983, to approve subject to conditions (modified) the Preliminary Plat of Springbrook, designated by the Building and Land Development Division, Department of Planning and Community Development, File No. 183-1, and the Council does hereby adopt as its action the recommendation (s) contained in said report with the following amendment. Condition 23 is amended to read as follows:

23. The subdivision shall be developed in a minimum of two phases to be reviewed and approved by the Subdivision Technical Committee prior to plan and profile submittal. Phase I shall be limited to 114 dwelling units. The balance shall not be recorded until contracts are let for the improvements to 100th N.E. between 124th N.E. and 132nd N.E. If the contracts are not let prior to the recording of Phase II, the developer shall have the option of constructing N.E. 126th as a public half-street to King


