

ORDINANCE NO. 6475

AN ORDINANCE making an appropriation of \$2,609,855 to the County Road Fund (CIP Only) from the unencumbered Road fund balance; cancelling \$2,609,855 of appropriation authority in the Real Estate Excise Tax Fund: amending Ordinance No. 6213, Sections 51 and 76, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$2,609,855 to the County Road Fund (CIP Only) from the unencumbered Road fund balance to "Transfer to Fund 336" CIP Project No. 999878 in the amount of \$2,274,900, and to "Transfer to Fund 386" CIP Project No. 999977 in the amount of \$334,955 to replace Real Estate Excise Tax funds for Petrovitsky Road - Phase I, S.W. 116th Street, N.E. 195th Street, and Tolt Hill Road - Phase II.

SECTION 2. There is hereby approved and adopted a cancellation of \$2,609,855 in the Real Estate Excise Tax Fund.

SECTION 3. Ordinance No. 6213, Section 51, as hereby amended to read as follows:




