

ORDINANCE NO. 6601

AN ORDINANCE relating to fees charged for the use of King County Parks and Recreation Facilities and amending Ordinance Nos. 5783, 6027 and 6247 and K.C.C. 7.08.010 through 7.08.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 5783 as amended and K.C.C. 7.08.010 are amended to read as follows:

GENERALLY. All persons using King County owned and operated park and recreation facilities shall pay the service fees, which include taxes, where applicable, set forth in the following schedules in this chapter, effective January 1, ((1983)) 1984.

SECTION 2. Ordinance No. 5783 as amended and K.C.C. 7.08.020 are amended to read as follows:

A. SWIMMING POOL FEES (fees include sales tax)

- Public swims: 17 and under ...\$ .75 per person per session
- 18 and over ... 1.25 per person per session
- Twenty-five cent swims ..... .25 per person per session
- Adult only swims ..... 1.25 per person per session
- Senior citizens-60 years plus.. .75 per person for any program session

B. SWIM LESSONS: \$1.00 per half hour to \$10.00 per half hour

C. POOL RENTALS

- 49 persons or less .....\$25.00 per hour + sales tax ((per-hour))
- 50-99 persons..... 29.00 per hour + sales tax ((per-hour))
- 100-150 persons..... 31.00 per hour + sales tax ((per-hour))

or 20% of the gross, whichever is greater

SECTION 4. Ordinance Nos. 5783 as amended and 6027 and K.C.C. 7.08.040 are amended to read as follows:

A. FEE STRUCTURED PROGRAM

Class fees.....Range \$5.00 per class to \$50.00 per class

Registration fee..... \$5.00 per participant per registration

for all fee structured classes, special

events or athletic fee programs and activities requiring pre-registration. \$1.00 per participant for all workshops, special events, seminars meeting one time only (i.e., 1 day). Registration fees will not be charged for regularly scheduled programs or events which are intended solely for the enjoyment of citizens 55 years or older.

B. ENTRY AND TOURNAMENT FEES (Leagues, tournament and special events fees to include officials, awards, sports equipment, administration fees and association fees)

- Adult Men's/Women's Leagues.....\$100-\$600 per team/league
- Adult Men's/Women's Tournaments.....\$50-\$200 per team/league
- Individual dual sports events.....\$5 - \$50 per participant

C. ADULT FIELD USAGE FEES

5. Group E - Outdoor Facility Use Fee

(Any groups renting outdoor facilities for activities including, but not limited to, dog shows, outdoor weddings, day camps, Fun Runs and organized picnics will pay according to the following fee schedule)

1 to 100 participants..... \$10.00 per day

101 + participants..... 10¢ per participant per day

Any groups using outdoor facilities who charge a participant fee will be assessed the above rental rate plus 10% of gross revenue.

All groups will be assessed a \$2.00 handling fee per Reservation Form.

27 establishing "no charge" to civic or non-profit organizations for the use of  
28 activity centers during program hours shall be April 5, 1982, the date  
29 Ordinance No.5935 was adopted by the Council.

30 SECTION 5. Ordinance No. 6247, Section 5, K.C.C. 7.08.050 is hereby  
31 repealed.




