

ORDINANCE NO. 6925

2 AN ORDINANCE relating to housing and community
3 development; appropriating \$549,000 of federal
4 Rental Rehabilitation Program funds to the
5 Community Development Block Grant Fund, authorizing
6 the King County executive to execute grant
7 agreements for the funds, redistributing Community
8 Development Block Grant funds currently programmed
9 for rental rehabilitation, and amending Ordinance
10 No. 6597, Section 59, as amended.

11 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

12 SECTION 1. There is hereby approved and adopted an
13 appropriation of \$549,000 to the Community Development Block
14 Grant Fund from an existing 1984 United States Department of
15 Housing and Urban Development, hereinafter referred to as
16 "HUD", grant of \$274,500, and from a pending 1985 HUD grant
17 of \$274,500. Funds are to provide rehabilitation assistance
18 for rental property housing low and moderate income tenants
19 in King County.

20 SECTION 2. The King County executive is hereby
21 authorized to enter into grant agreements with HUD for the
22 1984 and 1985 federal Rental Rehabilitation Program funds.

23 SECTION 3. The existing appropriation for the Low Income
24 Rental Housing Rehabilitation Program shall be redistributed
25 to provide for operation of the federal Rental Rehabilitation
26 Program through December 31, 1985 in an amount not to exceed
27 \$120,000. Any Community Development Block Grant funds
28 remaining after program operation is provided shall be
29 available for reallocation by the county council.

30 SECTION 4. Ordinance No. 6597, Section 59, as amended,
31 is hereby amended to read as follows:
