

ORDINANCE NO. 7024

AN ORDINANCE authorizing King County to collect fees for Uniform Fire Code permits issued by the King County fire marshal.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Definitions of activities, operations, or locations subject to permit fees under the provisions of this ordinance shall be the definitions contained in the Uniform Fire Code, and such definitions are hereby adopted by reference.

SECTION 2. Definitions. The following terms as used in this ordinance shall have the respective meanings herein set forth.

A. INITIAL FEE. The fee for the first inspection for any activity, operation, or location conducted by the King County fire marshal or his designee under the provisions of this ordinance.

B. RENEWAL FEE. The fee for inspections for any activity, operation, or location conducted subsequent to the first inspection by the King County fire marshal or his designee, payable annually upon inspection.

SECTION 3. Each permit issued by the King County fire marshal under authority of the Uniform Fire Code shall be subject to the following annual fee schedule:
