2 AN ORDINANCE relating to the closure of portions of the
3 following public streets; 16th Avenue South, 17th Avenue
4 South, 18th Avenue South, 19th Avenue South, 20th Avenue
5 South, 21st Avenue South, 22nd Avenue South, 23rd Avenue
6 South, South 201st Street, South 202nd Street, South 203rd
7 Street, South 204th Street, South 205th Street, South 206th
8 Street, South 207th Street, South 208th Street, South 209th
9 Street, South 210th Street, and South 211th Street.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. A. Barricades shall be installed by the depart-
12 ment of public works to prevent vehicular use of the following streets:

- 13 1. 16th Avenue South, south of South 200th Street and north of South
14 212th
- 15 2. 17th Avenue South, south of South 200th Street and north of South
16 212th
- 17 3. 18th Avenue South, south of South 200th Street and north of South
18 212th
- 19 4. 19th Avenue South, south of South 200th Street and north of South
20 212th
- 21 5. 20th Avenue South, south of South 200th Street and north of South
22 212th
- 23 6. 21st Avenue South, south of South 200th Street and north of South
24 212th
- 25 7. 22nd Avenue South, south of South 200th Street and north of South
26 212th
- 27 8. 23rd Avenue South, south of South 200th Street and north of South
28 212th
- 29 9. South 201st Street, east of 15th Avenue South and west of 23rd
30 Avenue South
- 31 10. South 202nd Street, east of 15th Avenue South and west of 24th
32 Avenue South
- 33 11. South 203rd Street, east of 15th Avenue South and west of 24th
Avenue South
12. South 204th Street, east of 15th Avenue South and west of 24th
Avenue South

- 1 13. South 205th Street, east of 15th Avenue South and west of 24th
- 2 Avenue South
- 3 14. South 206th Street, east of 15th Avenue South and west of 24th
- 4 Avenue South
- 5 15. South 207th Street, east of 15th Avenue South and west of 24th
- 6 Avenue South
- 7 16. South 208th Street, east of 15th Avenue South and west of 24th
- 8 Avenue South
- 9 17. South 209th Street, east of 15th Avenue South and west of 24th
- 10 Avenue South
- 11 18. South 210th Street, east of 15th Avenue South and west of 24th
- 12 Avenue South
- 13 19. South 211th Street, east of 15th Avenue South and west of 24th
- 14 Avenue South

15 B. The streets listed above in paragraph A shall be closed to all
 16 vehicular traffic, except fire, police or other emergency equipment, until
 17 further notice.

18 C. Public notice of these street closures shall conform to the
 19 requirements of R.C.W. 47.48.020.

20 SECTION 2. This ordinance shall not be interpreted as preventing King
 21 County from issuing permits pursuant to KCC Title 14 for the use of the
 22 streets closed above in Section 1, nor allowing destruction or covering of
 23 said streets.
