ORDINANCE NO. 7043

AN ORDINANCE establishing the date for an election on the question of annexation; and assumption of indebtedness of certain unincorporated territory contiguous to the City of Tukwila located within the McMicken Heights area; and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The City Council of Tukwila by Resolution No. 907 and 920 has expressed its support for the proposed annexation.

SECTION 2. Resolution 920 does satisfy the provisions of RCW 35A.14.020 requesting the calling of an election to be held among the qualified voters therein.

SECTION 3. The King County Boundary Review Board has approved the proposal as submitted on October 11, 1984, all in accordance with RCW 36.93.100.

SECTION 4. A special election shall be held on the 5th day of February, 1985, within the proposed annexation area on the question of whether or not said area should be annexed to the City of Tukwila; and that all property within the area to be annexed, shall, upon annexation, be assessed and taxed at the same rate and on the same basis as property within the City of Tukwila is assessed and taxed to pay for all or any portion of the outstanding indebtedness of the city, including assessments for taxes in payment of any bonds issued or debts contracted prior to or existing as of the date of annexation.

SECTION 5. The boundaries of the territory proposed for annexation are hereby described as follows:

1 Beginning at the intersection of the Tukwila City limits
2 and the south right-of-way margin of State Highway 518;
3 thence westerly along said south right-of-way margin of
4 State Highway 518 to the east right-of-way margin of 42nd
5 Ave. South; thence south along said east right-of-way
6 margin of 42nd Avenue South to the south right-of-way
7 margin of South 164th Street; thence east along said south
8 right-of-way margin of South 164th Street to the Tukwila
9 City limits; thence northerly along said Tukwila City
10 limits to the south right-of-way margin of State Highway
11 518 and to the beginning.

12 SECTION 6. Notice of election shall be published as
13 required by law.

14 SECTION 7. The county council finds as a fact and declares
15 that an emergency exists and that this ordinance is necessary
16 for the immediate preservation of public peace, health or
17 safety or for the support of county government and its existing
18 public institutions.




