

ORDINANCE NO. 7300

AN ORDINANCE authorizing the County to enter into a multi-year lease for the Dexter Horton Building; making an appropriation of \$29,205 to CIP Project No. 002200, Dexter Horton Building lease, from the River Improvement Fund and Public Works Administration; appropriating \$91,000 to Current Expense Special Programs from unappropriated Current Expense fund balance; and amending Ordinance 7027, Sections 37 and 83, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County council authorizes the King County executive to sign a multi-year lease for the Dexter Horton Building. The lease agreement is provided in Attachment A.

SECTION 2. There is hereby approved and adopted an appropriation of \$29,205 to CIP Project No. 002200, Dexter Horton Building lease; for the purpose of making monthly payments in 1985, from various agencies in the Department of Public Works.

SECTION 3: There is hereby approved and adopted an appropriation of \$91,000 to Current Expense Special Programs from unappropriated Current Expense fund balance; for payment of a termination fee for the June 21, 1985 lease in the Dexter Horton Building. Ordinance No. 7027, Section 37 as amended is hereby amended by adding thereto and inserting therein the following:
