ORDINANCE NO. _____

AN ORDINANCE relating to fees charged for the use of King County Parks and Recreation Facilities and amending Ordinance No. 5225, as amended, and K.C.C. 7.08.010 and 7.08.030.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No., 5225 as amended and K.C.C.

7.08.010 are amended to read as follows:

All persons using King County owned and operated park and recreation facilities shall pay the service fees, set forth in the following schedules, effective January 1, ((1985)) 1986.

SECTION 2. Ordinance No. ~~5225~~ as amended and K.C.C.

7.08.030 are amended to read as follows:
