

ORDINANCE NO. 7669

AN ORDINANCE making a supplemental appropriation of \$1,389,181 for jail operations; from Special Programs, Executive Contingency and from the Current Expense Fund Balance; amending Ordinance No. 7422, Sections 26, 39, 45, 59, and Section 78, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$1,389,181 for jail operations; \$560,300 from Special Programs, Executive Contingency and \$828,881 from the Current Expense Fund Balance. The appropriation will fund: (1) one-time costs and other unanticipated overtime and extra help costs incurred from January through June 1986 as a result of the transition in moving to a new jail facility; and (2) additional staff and other operations and maintenance costs to meet unanticipated workloads and/or jail population increases.

SECTION 2. Ordinance No. 7422, Section 26 as amended, is hereby amended by adding thereto and inserting therein the following:

From the Current Expense Fund there is hereby appropriated to:

Facilities Management \$ 208,857

SECTION 3. Ordinance No. 7422, Section 39 as amended, is hereby amended by adding thereto and inserting therein the following:

From the Current Expense Fund there is hereby appropriated to:

Adult Detention \$1,135,313

SECTION 4. Ordinance No. 7422, Section 45 as amended, is hereby amended by adding thereto and inserting therein the following:

From the Current Expense Fund there is hereby disappropriated from:

Executive Contingency \$(560,300)

SECTION 5. Ordinance No. 7422, Section 59 as amended, is hereby amended by adding thereto and inserting therein the following:

From the Public Health Pooling Fund there is hereby appropriated to:

King County Divisions \$ 45,011

SECTION 6. The project information sheet attached hereto is adopted to amend and revise the 1986 Capital Improvement Program, amending Ordinance No. 7422, Section 78, Attachment No. 1, as amended.

PROVIDED THAT in no instance shall this funding be used to provide civilian maintenance positions to perform tasks previously done by inmates in the old jail facility.


PROVIDED FURTHER THAT in no instance shall inmates be assigned to jobs in the new facility which were being performed by labor union members in the old facility.

PROVIDED FURTHER THAT custodial tasks performed by inmates under Department of Adult Detention supervision in the old jail facility shall be performed by inmates in the new jail.




