ORDINANCE NO. 7689

AN ORDINANCE appropriating \$1,133,603 to the solid waste division to support increased activity in planning, waste reduction and recycling, engineering, maintenance and upgrading of Cedar Hills Sanitary Landfill, from the Solid Waste Operating Fund balance; appropriating \$124,000 to Project No. 003091, Cedar Hills Pump Station 1, \$435,000 to Project No. 003092, Cedar Hills North Leachate Collector Reconstruction, and \$88,350 to Project No. 003085, Cedar Hills Leachate System Evaluation, from Solid Waste 1981 Construction fund balance and from the Solid Waste Operating fund; and amending Ordinance No. 7422, Sections 66 and 78, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$1,133,603 to the Solid Waste Operating fund to support planning, waste reduction/recycling, and meeting of minimum functional standards and federal court order from the Solid Waste Operating fund balance.

SECTION 2. Ordinance No. 7422, Section 66, as amended, is hereby amended by adding thereto and inserting therein the following:

2 Hills Leachate System Evaluation, from 1981 Solid Waste  
3 Construction fund balance and from the Solid Waste Operating

5 SECTION 4. Ordinance No. 7422, Section 78, as amended, is  
6 hereby amended by adding thereto and inserting therein the

9 are hereby appropriated and authorized to be disbursed the  
10 following amounts for the specific projects identified in  
11 Attachment 2 of this ordinance.






