

ORDINANCE NO. 7707

AN ORDINANCE relating to the annexation of an area known as 85-2 to King County Water District No. 82.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as 85-2 to King County Water District No. 82 was filed with the county council effective July 1, 1986.

2. King County Water District No. 82 has found the petition for annexation to be sufficient and has, by Resolution No. A-663 concurred with the proposed annexation.

3. King County Water District No. 82 filed a Declaration of Non-significant Impact dated February 19, 1986 on the proposed annexation.

4. The county council held a public hearing on the 28th day of July, 1986 and has considered the criteria set forth in R.C.W. 56.02.060 and R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 82 of the area known as 85-2 and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 and R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on 85-2.

SECTION 2. King County Water District No. 82 is the appropriate entity to serve the area proposed to be annexed.

Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

SECTION 4. The area known as 85-2 to be annexed is described as follows:

Situated in Section 14 and Section 23, Township 24 North, Range 6 East, W.M., King County, Washington, described as follows:

That portion of the Southwest quarter, Section 14, lying North of the Southern margin of Issaquah-Fall City Road except that portion already annexed to Water District #82 by Resolution No. 33409.

AND

That portion of section 23 lying North of the southerly margin of Issaquah-Fall City Road.
