ORDINANCE NO. 7777

AN ORDINANCE appropriating \$28,500 to Big Finn Hill Park and \$3,000 to Edith Moulton Park in the Parks, Recreation and Open Space fund, from a transfer from Northshore Neighborhood Park #4 in the Parks Acquisition and Development Fund; and amending Ordinance No. 7422, Section 78, Section 79, and Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$28,500 to C.I.P. Project No. 040045, Big Finn Hill Park, and \$3,000 to C.I.P. Project No. 081750 Edith Moulton Park, in the Parks, Recreation and Open Space fund from a transfer of \$31,500 from C.I.P. Project No. 081321, Northshore Neighborhood Park #4 in the Parks Acquisition and Development Fund.

SECTION 2. Ordinance No. 7422, Section 78, Attachment No. 1, as amended, is hereby amended by adding thereto and inserting therein the following:

From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment No. 1 as adjusted by Attachment No. 2 of this ordinance.


